NOGLSTP Launching Mentoring Program

NOGLSTP is proud to announce the coming launch in early January of a new initiative. It is an international mentoring program for LGBTQ students in the sciences, engineering, and technical professions. NOGLSTP member Amy Ross, Ph.D., has volunteered to coordinate the program. NOGLSTP is in the early stages of developing the mentoring program for LGBTQ students to connect them with established professionals and human resources pipelines at top science, engineering, and high-technology companies. Integral to the mission will be an affiliated partnership with MentorNet, a non-profit ementoring portal that already services women and underrepresented minorities in these fields. The overview of the vision was presented in late September at the Out and Equal Workplace Summit. NOGLSTP is currently putting together a grant proposal to fund this project and is looking for appropriate funding sources. In addition, talks are underway with various industry employee resource groups to seek sponsorship for career fairs and career conferences for these students, early career professionals, and out of work professionals seeking to re-enter the workforce. NOGLSTP will work face-to-face with universities, professional societies, and industry by presenting workshops on the value of LGBT mentoring and providing them with access to the mentoring network.

Bannochie Receives ACS Award

NOGLSTP Member Chris Bannochie has been selected as the

recipient of ACS's 2005 Stanley C. Regional Israel Award for Advancing Diversity in the Chemical Sciences. Bannochie, an American Chemical Society Councilor for the Savannah River Section, has been recognized for his leadership in es-

tablishing and fostering inclusiveness and recognition of LGBT members of ACS and the broader scientific and professional communities. In particular, this award was given to him in recognition of his work leading to the ACS Policy Statement 2003-14 that recommends federal legislation to extend employment discrimination protection to include sexual orientation, gender expression, and gender identity. The award was presented to Bannochie at the Southeast/Southwest Regional American Chemical Society Meeting in Memphis earlier this month. The award was named after deceased American Chemical Society Director Stanley C. Israel, who was dedicated to the cause of inclusiveness and diversity in the chemical profession and society at large.

Outreach at the Association of Science-Technology Centers Conference

NOGLSTP Member Judd Proctor reports that there was a GLBT Reception at the annual conference of the Association of Science-Technology Centers in Richmond, Virginia this past October. Thirty-second, mini-history statements about famous GLBT scientists were announced on the local FM radio (WRIR, 97.3FM) the Thursdays before and after the conference.

Congratulations are in order for Mark Tumeo, who won his bid for election to the Cleveland Heights City Council. Dr. Tumeo, Vice-Provost for Research and Dean of Graduate Studies at Cleveland State University, is a long-time NOGLSTP member, and served on our Board of Directors for over ten years.

2005 Out & Equal Workplace Summit

NOGLSTP presented a well-attended, standing room only, workshop at the 2005 Out & Equal Workplace Summit held late September in Denver Colorado. This was especially gratifying as it is NOGLSTP's inaugural effort in its new mentoring program. Entitled "Mentoring Young LGBT Scientists, Engineers, and Technical Professionals: Fostering Academic, Corporate and Professional Society Partnerships", the workshop featured academic, corporate, and professional association executives. The panel featured NOGLSTP members Amy Ross (moderator and NOGLSTP Mentoring Program Coordinator) and Rochelle Diamond (NOGLSTP chairperson), along with Miriam Feldblum (Special Assistant to the President of Caltech and Student Affairs Liason for GLBT groups on campus), Chase Hawkins (Director for Diversity at Raytheon Integrated Defense Systems), and Jeffrey Ehrenberg (Learning Leader for IBM Research). The participants discussed the NOGLSTP vision of a targeted mentoring program that will assist students and entry-level professionals with practical guidance and the tools to succeed. In today's highly competitive environment, the next generation of LBGT scientific, engineering, and technology professionals must be able to successfully integrate their unique knowledge and skills into the corporate workplace. Such alliances will be mutually beneficial to LGBT students, professionals, and the corporate world

In addition, NOGLSTP was pleased to accept the donation of IBM's exhibition booth for the duration of the Summit. NOGLSTP displayed its various brochures and gave away its first ever NOGLSTP pens with the NOGLSTP logo and website imprint. A new color NOGLSTP general information brochure was also introduced at the summit.

Out & Equal[™] Workplace Advocates is a national nonprofit 501(c)(3) organization headquartered in San Francisco. They champion safe and equitable workplaces for lesbian, gay, bisexual, and transgender (LGBT) people. They advocate building and strengthening successful organizations that value all employees, customers, and communities. This kind of networking raises the profile of NOGLSTP with the 1,060 participants at the Summit who gathered to share best practices on how to achieve workplace equality for LGBT employees. Participants represented 223 companies and organizations in 39 states and abroad, including attendees from Canada, Germany, Kazakhstan, the Netherlands and the United Kingdom. The 2006 Summit will be held next September in Chicago.

LGBT Chemists and Allies

NOGLSTP sponsored a well-attended reception for LGBT Chemists and Allies at the Fall National American Chemical Society Meeting this past August, in Washington DC. ACS has two national meetings a year. The LGBT Chemists and Allies usually have an informal gathering, such as a night "out", and NOGLSTP hosts a reception at the fall meeting. We're looking forward to the next fall meeting, which will be in San Francisco, September 10-14, 2006!

SACNAS National Conference

NOGLSTP Chairperson, Rochelle Diamond, attended the first ever-official LGBTQ forum at the Society for the Advancement of Chicano and Native American Scientists (SACNAS) National Conference in Denver. This forum was a big step for SACNAS whose mission is to encourage Chicano/Latino and Native American students to pursue graduate education and obtain the advanced degrees necessary for science research, leadership, and teaching careers at all levels. SACNAS is over 30 years old and membership spans several different age and education ranges.

Even though Rochelle is not ethnically a member of SACNAS, as chairperson of NOGLSTP, she was invited to talk about the issues facing LBGTQ students and early career professionals who are also women and under-represented minorities pursuing their fields of study. The event was a well-attended panel discussion with much input from the audience. Unfortunately this forum was the last session of the entire conference and the attendees really didn't get a proper chance to network and discuss the issues amongst themselves. Many in the audience have since contacted her to try and organize a similar forum for next year with a reception at the beginning of the meeting so that people would have a chance to make contact with each other during the meeting. NOGLSTP will try to help the SACNAS LGBTQ community to raise sponsorships and awareness of the need for such programming.

Society of Women Engineers

Rochelle Diamond and Amy Ross hosted a NOGLSTP reception at the Society of Women Engineer's (SWE) National Conference in Anaheim, CA. The reception was held in honor of the first ever diversity track session for LBGTQ women engineers. Entitled "Homeward Bound – Companies Welcoming the Whole You, from Gender to Sexual Orientation/Invisible Diversity in Engineering". The session was graciously sponsored by Out and Equal and DuPont. NOGLSTP very excited about expanding contact with SWE and they are very interested in the launch of NOGLSTP's Mentoring Program. SWE is already a partner with MentorNet, representatives of which attended the SWE reception.

National Engineering Week



Queer Scientists of Contemporary Note:

Alexis Templeton and Amy Palmer

Earth scientist Alexis Templeton and biophysical chemist Amy Palmer have been together since their undergraduate days at Dartmouth. They have a one year old son, Ethan and all are embarked on a new life together at the University of Colorado, Boulder. Its hard enough to land a tenure-track job and even harder to search for two jobs together starting a family. So says the article in the October 21st issue of *Science*. Perhaps a sea change is occurring in some of the top academic institutions as they search for the best talent available and struggle to keep the talent within their institutions. These women have worked hard for the opportunity and were audacious enough to go after what they desired – good jobs for both in a comfortable environment. They have both supported each other through their careers, each taking turns at technical jobs while each finished a degree. Then on to co-interviewing for postdocs and now securing faculty positions together. "Just a few years ago, any one of these complicating factors--the unconventional nature of their relationship; requiring two jobs in the same place; having a baby in the midst of the job search--could have caused problems. But "what we found is that many institutions have worked very hard in the last few years to be very open" to assisting new parents and dual-career couples, as well as about lifestyle choice, says Templeton: "I think the landscape has changed a lot."..."There wasn't a blink, which was really astounding," says Templeton.
